# Attention Exhibitors

Entries must be made on an official American Kennel Club form, signed by the actual owner or by his duly authorized agent and received by the closing date specified in the premium list. Please type or print neatly and check all information on your entry form.

Entries will not be accepted, canceled, altered, or substituted after the closing date. The club assumes no responsibility for wrong or incomplete information on the entry forms.

Entry fees shall not be refunded in the event a dog is absent, disqualified, excused by the veterinarian or judge, barred from competition by action of the obedience trial committee, or because it has been entered incorrectly. Entry fees will not be refunded for duplicate entries.

Entry fees will not be refunded in the event a bitch entered in the trial comes into season after entries close. Bitches in season will not be allowed on the trial grounds.

Unentered dogs will not be allowed on the trial grounds.

At the trial, dogs need to be present only at the scheduled time of judging according to the judging schedule. The club and its trial secretary will not be responsible and are not obligated to furnish any kind of service for notifying exhibitors or their agents of class judging.

Training of dogs on the trial grounds and the use of spiked or other special training collars within the trial precinct is strictly forbidden.

The trial-giving club, the trial secretary, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Returned checks do not constitute a valid entry fee. The secretary will add a collection fee to the amount of each returned check. The ruling date for ages and titles in awards is the closing date. Only dogs entered in regular classes may compete for trophies or special prizes and a *qualifying score is required.*

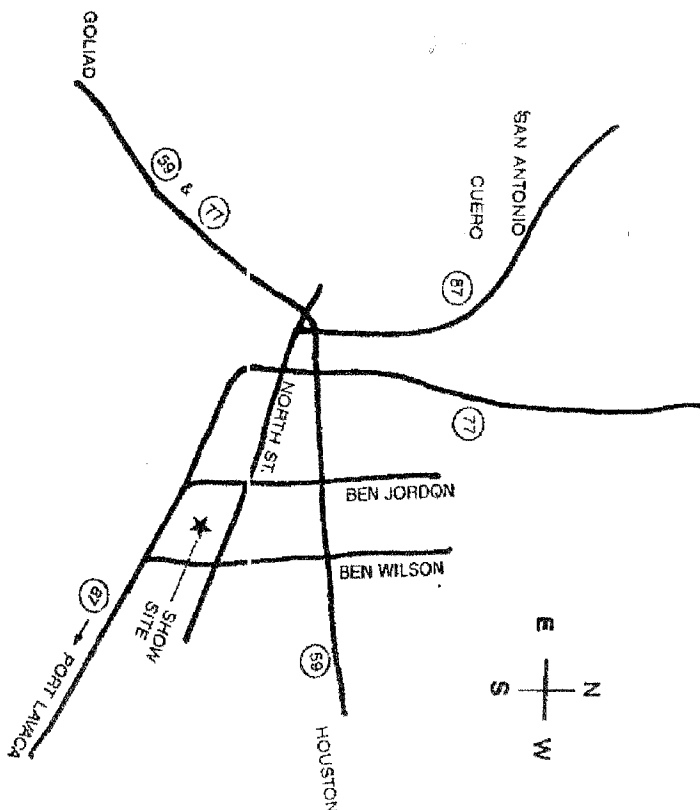

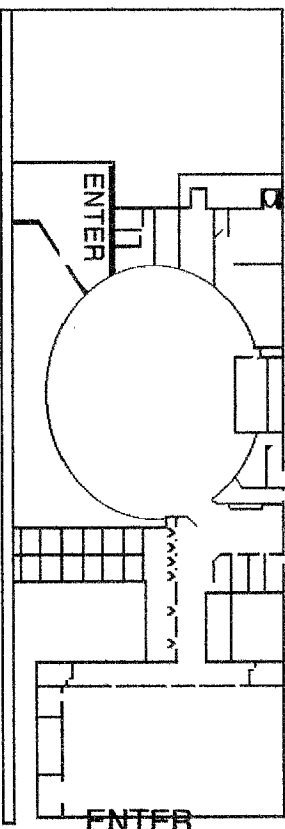

## AGREEMENT

I (we) acknowledge that the "Rules Applying to Registration and Dog Show" and, if this entry is for an obedience trial the "Obedience Regulations," have been made available to me (us), and that I am (we are) familiar with their contents. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this show or obedience trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

## INSTRUCTIONS

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-colored). Beagles (not exceeding 13 in. over 13 in. but not exceeding 15 in.). Dachshunds (longhaired, smooth, wire-haired). Bull Terriers (colored, white). Manchester Terriers (standard, toy). Chihuahuas smooth coat, long coat). English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles). Poodles (toy, miniature, standard, Collies (rough, smooth).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A. K. C. (For complete rule refer to Chapter 14, Section 3).
